- ➤ Mission: Promote the science and art of medicine, the care and wellbeing of patients, the protection of the public health, and the interests of the medical profession




The Medical Society keeps an extensive database on all physicians in Humboldt and Del Norte County, which allows us to:

Humboldt PreMedical Education Committee

Committee works with Humboldt-Del Norte County Schools, College of the Redwoods, Cal Poly Humboldt, Medical Schools and their rural rotation programs, and our Family Medicine Residency Program - and their health career pathway programs to coordinate physician speakers, shadowing opportunities, mentoring, mock interviews, career fairs, etc. To help build our future pipeline of physicians.

Humboldt-Del Norte Future Physician Scholarship Program

Scholarship program set up through Humboldt Area Foundation to give two \$1,000 scholarships to students applying for medical school and wanting to come back to Humboldt-Del Norte to practice.

MEMBERSHIP COMMITTEE

- Membership Recruitment and Retention.
- Reviews applicants and makes recommendations to the Executive Committee
- Welcoming Committee for new physicians.

PUBLIC SERVICE AND MEDICAL ETHICS COMMITTEE

- ➤ Mediates patient-physician complaints for MEMBERS ONLY
- > If the physician is not a member, the patient will be referred to the Medical Board of California or the Osteopathic Medical Board

PHYSICIAN SUPPORT COMMITTEE

 Addresses issues relating to the health, well-being or impairment of physicians, in order to maintain and improve the quality of care and assist in the maintenance of appropriate standards of personal performance

PUBLIC HEALTH ADVISORY COMMITTEE (Ad Hoc)
