#### In what ways can I get involved with affecting change through the CMA or its subsidiaries?

CMA encourages our membership to be advocates and active in influencing change for physicians throughout California. Your county medical society is an excellent resource and means for you to have an active voice in the California physician community through a variety of programs and committees. CMA also provides a variety of ways for you to get involved:

1.CALPAC-CALPAC is the California Medical Association Political Action Committee which supports candidates and legislators who understand and agree with the views of the physicians of CMA on medical issues. - 2.Legal Defense Fund-The Legal Defense Fund of the CMA is a collection of monies voluntarily contributed by CMA members to provide monetary support in cases, generally brought by our members, which seek to protect or establish important legal rights of physicians. - 3.Legislative Key Contact-CMA maintains an active network of physicians and their spouses as Legislative Key Contacts in each legislative and Congressional district. - 5.Institute for Medical Quality-The Institute for Medical Quality (IMQ) is a non-profit organization dedicated to improving the quality of care provided to patients across the continuum of health care. IMQ has a variety of accreditation programs in which physicians are a part of the surveying process. Physicians interested in participating as a hospital, ambulatory surgery center, correctional facility or continuing medical education surveyor should contact IMQ at (415)882-5151.

#### How can I get involved in shaping CMA policy?

CMA encourages its membership to be involved with the shaping of CMA policy. CMA policy is decided upon annually at the House of Delegates, CMA's legislative body that establishes the policies that govern the Association and elects CMA's president. CMA members can participate in the House of Delegates policy-making process in a variety of ways:

- 1. Authoring a Resolution-Any CMA member can author a resolution for introduction to the House by a delegation or individual delegate or alternate delegate. A resolution can address virtually any health-related topic or any aspect of the policies and activities of CMA. For examples of writing a resolution please visit the House of Delegate section of CMA's website by logging onto the members side at www.cmanet.org/logon and navigating to the "Organizational Structure" choice under pull down found at "Other Quick Links." Completed resolutions may be e-mailed to resolutions@cmanet.org. Be sure to forward a copy of the resolution to the local medical society to be forwarded to the elected Delegates and Alternate Delegates that will be attending the meeting and can speak in reference to your resolution.
  - 2.Participation as Delegate or Alternate Delegate-CMA members also can participate directly in the House of Delegates through election as a delegate or alternate delegate by their county medical society, state specialty society, mode of practice forum, or one of the CMA sections in which they participate. For more information about election as a delegate or alternate, members should contact the Humboldt-Del Norte County Medical Society, 442-2367 (465-0980)
  - 3. **Testifying at Reference Committee Hearings-**Any CMA member may present testimony (i.e., speak for or against a resolution or recommendation) at reference committee hearings and may attend the meetings of the full House of Delegates as an observer.
  - 4.Committee Membership-Members also have the opportunity to seek nomination for membership on a CMA committee. Members must be selected by CMA's Committee on Nominations or appointed by the Chair of CMA's Board of Trustees in order to participate in a committee. We encourage you to express interest in a nomination through your county medical society. The county societies will then submit nominations to the CMA.
- 5.CMA Forums-CMA sponsors several forums targeted to physicians engaged in various modes of practice. Each CMA member belongs to the mode of practice forum the physician selects as best describing the physician's practice situation. The forums include administrative medicine, academic practice, government employed, hospital based, solo & small group, medium sized group, large group and very large group. All mode of practice forums elect an executive body that functions as the leadership of that respective forum to make decisions on policy or other related issues. In addition each mode of practice forum elects representatives to be Trustees and/or Delegates or Alternates in the House of Delegates. 1)Log onto the Members' Section of CMA's website (per the instructions above)

- 2) Once in the Members' Section, scroll down to the bottom of the page and click on "search."
- 3) You will notice that the Policy Compendium now appears as one of the resources you can search.
- 4) Now, remember to follow the search instructions on the page, and you should be all set. You can search the Policy Compendium by key word(s), topic, or by year.

How do I verify my California license number as well as get information on renewing my license?

How do I obtain a fictitious name permit for my practice?

#### How do I renew, register for, or update my DEA license?

Information concerning the Drug Enforcement Administration (DEA) license can be obtained by contacting your local California DEA offices at (888)304-3251 for Northern California or by contacting the DEA Registration Center at (800)882-9539.

#### How do I make a complaint against a hospital?

Contact The Joint Commission on Accreditation of Healthcare Organizations (JCAHO). The Joint Commission, along with the California Medical Association, conducts surveys to be sure that hospitals are providing quality care. Ask them to investigate your complaint. You can call them at (630)792-5000. In addition, the government agency responsible for licensing and regulating hospitals is the California Department of Health Services (DHS). To file a complaint, you need to contact the district office in the area where the hospital is located.

How do I get information on having a survey of an acute care hospital for accreditation and licensure?

Contact the Institute for Medical Quality (IMQ), a subsidiary organization of the CMA, for information on their Consolidated Accreditation and Licensure Survey (CALS) Program which the Joint Commission on Accreditation of Healthcare Organizations (JCAHO), the Department of Health Services (DHS) and IMQ jointly perform. #### How do I get someone to come to my hospital to perform a peer review consultation?

Contact the Institute for Medical Quality (IMQ) for information on their Peer Review Consultation Program that provides objective peer review of the work of a member of a hospital's medical staff. IMQ may be reached at (415)882-5151.

#### How do I get information on preparing my medical staff for JCAHO and DHS accreditation?
