Redwood Coast PACE Update

Our local Program of All-Inclusive Care for the Elderly (PACE) turns 10 this year. We remain the only rural PACE program in the state of California. We started with 2 participants and now have over 300. We have a PACE center in Eureka and Fortuna, and a 3rd Center opening toward the end of this year in Arcata.

I recently spoke to public health officers from multiple rural counties about how to support health for older adults in rural California (via the California Center for Rural health Policy at Cal Poly Humboldt). PACE does provide a solid model of care, in its interdisciplinary approach, and mission to help people age in place. Getting a PACE program started in a rural area is not easy, though, and it will take continued advocacy and efforts to help rural older adults access needed services. Even in our community, PACE is a covered service for people with both Medicare and Medi-Cal, while those with only Medicare will have a share of cost. The National PACE Association is advocating with legislators to reduce barriers to care for all.

PACE originally developed in San Francisco over 50 years ago, when a dentist and social worker were tasked with planning a nursing facility for elders in Chinatown. The cultural dissonance of "placing" elders led these two to pursue a different route-which grew into PACE as we now know it. This involves a day center people can attend, transportation to appointments, in home care, medical and nursing care, social work supports, a dietitian and ensuring food insecurities are addressed, physical and occupational therapies and maybe most important the

creation of a community. In the PACE world the saying goes "if you've seen one PACE, you've seen one PACE". Though PACE is a highly regulated program, each specific site develops in a way that best serves its particular community.

Good geriatric care, or I should say good care for any age, involves time and attention. I recently saw that a bill is coming to the California legislature regarding more continuing education requirements for primary care physicians and other providers on dementia. While I am always in favor of education, I see this as trying to solve a problem by putting the onus on individual providers of care. Actually, most of us serving older adults have good education in dementia and other chronic illness care, but not enough time to do it. Except at PACE, which uses a model of high intensity, patient-centered care in partnership with the people that participate in our program. No system will ever be perfect, but allowing for the development of relationships over time, and a truly open-door approach to care that addresses social determinants of health as well as specific medical needs is a pretty good place to start.

I am in about my 22nd year as a physician in this community, and in a couple of months would qualify (by age) for PACE. As we all age, and set the stage for a sustainable place to do so in our county for our patients and friends and family and neighbors, it would behoove us to think about the systems of care that we choose to work in, and whether they allow us to realistically care for each other. All the education and RVU incentives in the world do not make a 15 minute visit adequate to address complicated matters

of health. We enjoy having residents and students rotate through PACE, as a chance to see another approach.

It continues to be an honor to serve as Medical Director, and I hope to see our program continue to grow and improve to meet the needs of our community. In August we will be welcoming a new full time physician who is fellowship trained in geriatrics, Dr Celeste Sayles-Croy. Dr Allison Burton, Dr Uzi Selcer, and our nurse practitioners Roxane Heiob and Susanne Ross round out our team. We appreciate calls and communication about our program and the care of our participants. We are "responsible" for our participants 24/7/365, and like to be involved in their care, so don't be surprised when we call colleagues for care coordination. It is a joy for us to be a part of the larger medical community, and offer our services to some of the most vulnerable people in our county. δ

Public Health Update

An update on the status of Avian Influenza (H5N1):

- The CDC, CDFA, and FDA are closely monitoring the progress of the Avian Influenza (H5N1) strain outbreak that has been occurring in wild birds across the country since 2022.
- Early this year, we began to see cases of H5N1 avian flu spreading to dairy cattle, now in several states. There have been three human cases associated with this in the US, as well as a handful of cases in other countries. In the US, all three cases have been mild and recovered without spread to contacts. There have been more serious illnesses and deaths reported in other countries.
- As of today (June 24th), there have been no human or dairy herd cases in California, although we have had confirmed cases in wild birds and other animals.

- We still assess the risk to the general population as low. The concern here is two-fold: it has a commercial impact since it affects dairy cows/goats, and this version of influenza (when passed to humans) could mix with other strains of influenza in a human host and produce something that is more concerning.
- Cows who become infected generally recover after a couple of weeks. This is different than in poultry, where nearly all infected birds die, and standard practice is to euthanize the entire affected flock. Milk produced by infected animals can carry the virus (early reports suggest the virus is concentrated in the udder); pasteurization is effective at inactivating the virus. No pasteurized milk has tested positive for the active virus. There are rumors circulating in some forums that drinking raw milk can help build your immunity for this: please remind your

- patients that there are multiple health risks associated with raw milk products.
- Dairy goats are included in the commercial animals at risk, and we've just been told that alpacas are being added to the list of at-risk herds (information still coming on this).
- Many people are asking how this may affect county fairs. Recommendations for county fairs are in the final stage of review and due to be released this week. No information yet on what the guidance will contain.
- The standard influenza A assays in your laboratories cannot distinguish between this and the more common strains of influenza A. If you do have a patient test positive for influenza A this summer, we are asking that you contact us to send the specimen to the public health lab for typing. Keep this in mind particularly with your patients who work with dairy animals. §

U.S. Supreme Court Dismisses EMTALA Case - Sending the Issue Back to Lower Courts

In a temporary reprieve for reproductive freedom, the U.S. Supreme Court today dismissed Idaho's appeal of a lower-court order that paused the state's near-total abortion ban. The action at least temporarily prevents interference with enforcement of the federal law that allows women to receive abortion care in emergency situations in which their health is at risk while the issue is returned to the lower courts.

At issue in these consolidated cases Idaho v. United States and Moyle v. United States - was whether state abortion bans trump long-standing federal law that requires hospitals to provide stabilizing treatment to any patient who presents to their emergency rooms. The federal **Emergency Medical Treatment and Labor** Act (EMTALA) requires hospitals to provide necessary abortion care to pregnant people experiencing medical emergencies irrespective of any conflicting state law. Every hospital in the United States that operates an emergency department and participates in Medicare is subject to EMTALA.

"The U.S. Supreme Court's ruling today is at least a temporary victory for patient rights. For 40 years, EMTALA has played an essential role in helping to stabilize pregnant people facing medical emergencies," said gynecologist and California Medical Association (CMA) President Tanya W. Spirtos, M.D. "With as many as 15% of pregnancies experiencing potentially life-threatening conditions, it is critically important that states with abortion bans are not allowed to endanger the lives of pregnant people by denying them the emergency care they need."

Being denied care has and will continue to result in increased maternal health complications and negative, long-term health effects for pregnant people, including loss of future fertility. Every pregnancy is different, and circumstances can change quickly. Health care providers need to be able to provide evidence-based care, which can include abortion, to protect the pregnant patient's life and health.

"As physicians, we at CMA stand strongly in support of the fundamental right to access reproductive health care services. While we are relieved that the Court ruling today prevents states from denying emergency medical care to pregnant patients, we know this fight is not over," said Dr. Spirtos. "CMA will continue to steadfastly champion policies that ensure that patients can get the care they need, when and where they need it, and that personal medical decisions can be made by individuals, in consultation with their health care providers, not by ideologically driven lawmakers or judges."

This action is the second in as many weeks taken by the U.S. Supreme Court on the issue of abortion access. Earlier this month, the Court ruled that the plaintiffs in Alliance for Hippocratic Medicine v. U.S. Food and Drug Administration (FDA) lack standing to sue over the FDA's approval of the abortion medication, mifepristone. While the Court did not rule on the merits of that case, the opinion for now preserves access to mifepristone, which was used in nearly two-thirds of all abortions in the U.S. last year.



Congress Reintroduces CMA-Supported Legislation to Reform Prior Authorization

Last week, 180 members of Congress, including 135 members of the U.S House of Representatives and 45 senators, introduced a strong, bipartisan bill to improve the prior authorization process for physicians and patients in Medicare Advantage, building on widespread support for prior authorization reform in the last Congress.

Supported by the California Medical Association (CMA), the American Medical Association (AMA) and nearly 400 health organizations, the updated Improving Seniors' Timely Access to Care Act of 2024 (S. 4532 / H.R. 8702) will streamline health plan bureaucracy to help ensure that Medicare patients can get the care they need, when they need it.

Prior versions of the bill garnered wide, bipartisan support, but stalled because of the high legislative cost of the bill. The updated bill features targeted policy changes to reduce the scored cost of the legislation.

This legislation will also codify in statute many of the reforms contained in the comprehensive prior authorization regulations recently finalized by the Centers for Medicare and Medicaid Service (CMS), which further reduces the cost of the legislation and will ensure another administration cannot rescind the regulations in the future. Specifically, the bill would:

Establish an electronic prior authorization process for Medicare Advantage plans, including standardization of transactions and clinical attachments.

Increase transparency around Medicare Advantage prior authorization by requiring plans to list all services subject to prior authorization, the number of services denied and overturned on appeal and the average and median amount of time that elapsed during the previous plan year between the submission of a specified request to the plan and the determination by the plan, by item and service.

Clarify CMS authority to establish tighter timeframes for health plan prior authorization decisions, and to implement and enforce real-time prior authorization decisions for routinely approved services.

Permit health plans to create gold-card programs.

At the state level, CMA continues to advocate for reforming the broken prior authorization process. This year, CMA is sponsoring SB 516, authored by Senator Nancy Skinner, which removes unnecessary prior authorization requirements; streamlines and modernizes the process for submitting and appealing a prior authorization request; provides transparency and data on health plan actions; and requires a physician of the same or similar specialty to conduct appeals of a prior authorization denial. §


